The applicant proposes to extend the hours to the Cigar Terrace as it has become a unique selling point of the Hotel and attracts smokers. When this facility is not available customers congregate on the street outside of the Hotel which can, on occasion, create the pathways to be congested along Manchester Street. The applicant also proposes to increase the cigar terrace seating area from 17 person to 22 excluding staff. See enclosed plan. The applicant proposes to erect a bar in the area as shown on the plans marked in red. This area is currently licensed but there is a condition on the existing premises licence which states no bar may be erected. Due to the location of the current bar facilities situated in the back of house, this creates a potential hazard. The applicant proposes to free up more space to ensure the optimal space is made available for the back of house team to work comfortably by erecting a small bar as shown on the plan in the licensed area. The applicant believes storage of alcohol would be better suited in a secure 'new bar area' and create a safer working environment by reducing the risk of fire by the removal of flammable items from the back of house (kitchen) areas. The current location of facilities has a detrimental effect on the applicants business, as an additional member of staff needs to be employed to ensure full coverage of the lounge which presents a negative effect on profit. The absence of a bar has been identified by in house surveys as being one of the reasons clients prefer to dine in other establishments as the lounge lacks ambience and a focal point. The erection of bar would help support the applicants current business. By creating a bar the applicant would hope to attract people to spend less time on the terrace freeing the area for cigar smoking connoisseurs.
